

**ANA TICKETS TERMS AND CONDITIONS**

- 1) ANA Tickets Prize: two (2) Economy Class round trip tickets on All Nippon Airways (“ANA”) from Seattle to Tokyo (“ANA Tickets”). The Approximate Retail Value of the ANA Tickets is \$ 3000.00.
- 2) Eligible Flights: Flights must be NH operated and marketed flights routed as SEA-TOKYO-SEA only. Codeshare flights are not eligible.
- 3) Reservations: Space is limited and we request that you book well in advance to obtain the best availability options.
- 4) Ticketing: ANA Tickets must be issued no later than 14 days prior to departure once seats are confirmed.
- 5) Minimum stay is 3 days and maximum stay is three (3) months from date of issue. Once ticketed, no changes are allowed.
- 6) Trip Completion Date: Round trip travel must be completed no later than December 10, 2023, and cannot be extended for any reason including but not limited to government restrictions on travel to or from Japan.
- 7) Winner is responsible for all travel costs associated with using the ANA Tickets (except the cost of the tickets), including but not limited to transportation costs to/from the Seattle airport, and all costs incurred while traveling in Japan.
- 8) Departure taxes, inspection fees and airport taxes are the responsibility of the Winner and must be paid in US\$ by credit card at time of booking. Please verify the amount applicable with an ANA representative.
- 9) Winner and companion, if any, must travel together on all flights. If winner’s companion is a minor, the minor must be accompanied by his/her parent or legal guardian.
- 10) Seat confirmation depends on availability and neither upgrade nor mileage credit is permitted. ANA Tickets have inventory restrictions. There may be cases when, due to their booking class, seats are not available for a flight which has seat availability for other booking classes. ANA is not liable for limited seat availability due to ANA Tickets’ booking class.
- 11) Travel is not permitted on December 15, 2022 through January 9, 2023, April 22, 2023 through May 8, 2023, or July 29, 2023 through August 20, 2023.
- 12) ANA Tickets are non-transferable, non-refundable, non-endorsable and may only be used by the person(s) to whom they are awarded. Changes are not permitted once an award ticket is issued.
- 13) Travel awards that are sold, bartered or altered are automatically void.
- 14) Travel awards offered have no cash value, other than the fees paid once ticketed. If ANA Tickets are lost, stolen or expire prior to use (unless restricted by law), they will be forfeited.
- 15) Identification is required at the time of travel. Winner and companion, if any, are solely responsible for compliance with all required visa, immigration and customs requirements for travel to and from Japan. No refunds or rescheduling will be made if improper documentation or failure to comply with all rules and regulations of the travel provider results in denying boarding or entry.
- 16) All tickets are subject to the vagaries of flight variations, work stoppage, schedule or route changes and government restrictions.
- 17) Winner must comply with all ANA requests for documents (including signed documents) related to issuing the ANA Tickets within the deadlines set by ANA, including but not limited to a signed W-9 form. ANA will not be responsible for any requests or correspondence delayed, lost or not received by either winner or ANA.
